ORDER GRANTING MARKUSCH DEFENDANTS' MOTION TO DISMISS

THIS MATTER has come before the Court on the Motion of Defendants Susan Markuschs" and Olson Real Estate Services, LLC (the "Markucsh Defendants") and the Court being now fully advised in the matter, hereby **ORDERS**:

- (1) Plaintiff Harvey Sender, as Receiver for Gary Dragul, GDA Real Estate Services, LLC, and GDA Real Estate Management, LLC (the "Receiver") lacks standing to bring the claims for relief asserted against the Markusch Defendants. The Receiver's Complaint is therefore **DISMISSED** with prejudice, pursuant to C.R.C.P. 12(b)(1), as to Susan Markusch and Olson Real Estate Services, LLC.
- (2) The Receiver's claims for relief asserted against the Susan Markusch fail for a lack of particularity and for otherwise not stating a claim upon which relief can be granted. The Receiver's Complaint is therefore **DISMISSED** with prejudice, pursuant to C.R.C.P. 12(b)(5) and 9(b), as to the Markusch Defendants; and

(3) The Receiver's Complaint fails to join indispensible parties whom have not be shown to to be impractical or impossible to join. Accordingly, Receiver's Complaint is thus DISMISSED with prejudice, as a matter of law, pursuant to C.R.C.P. 12(b)(6) as to the
