 Undersigned counsel certifies that she conferred with counsel for Defendant Gary Dragul ("Defendant"), and counsel for Defendant does not oppose this motion.

2. On June 14, 2022, the Parties filed their Twelfth Status Report with Request for Extension of Stay for 120 days.

3. On October 7, 2022, based upon motions filed by Defendant to vacate, continue, and reschedule his jury trials, the Court ordered trial to be reset in Arapahoe County District Court criminal case 2018CR1092. Also on October 7, 2022, the Court reset an eight-day trial to commence June 5, 2023, in 2018CR1092.
